- The **Kronos upgrade project** is underway. We are upgrading our system from v7 to v8.1.
- The legacy Providence Health go-live date for the Kronos upgrade is May 19, 2019. This will affect all Providence, Swedish, Facey, Kadlec, and PacMed caregivers.



Project Updates

- Training and support resources will be made available to you after April 1 to help you learn new functionalities and workflows in Kronos v8.1.
- Focus group sessions for schedulers were conducted in January and February to finalize enterprise workforce scheduler design.

Advanced Scheduling, WFS Managers & Schedulers **Improved employee self-service –** Scheduling features are available on one screen, plus new request types, such as requesting only part of an open shift.

**Self-scheduling enhancements –** Easy-to-use employee self-scheduling includes a two-week view, shift visibility, and a search option.

### Q1. Are clock/badge readers changing too?

No, clock/badge reader functionality and badge swipes will remain completely unchanged.

#### Q2. Can I return to the previous version after go-live?

No, this will be the version of Kronos that all caregivers will use going forward.

#### Q3. Will external access still be available?

Yes, you can still use the external web link to access Kronos from any device.

### Q4. Will I be able to access Kronos through my mobile device?

While we will not be enabling access through the official Kronos Mobile App, you can access the system directly via the external link through your smartphone's web browser.

#### Q5. Are reports changing?

There will be no changes to report designs.

### Q6. Will my previous customizations be available after the upgrade – HyperFinds, "My Favorites," and others?

Your preferences and customizations are not changing and will be carried forward to Kronos v8.1. The most notable difference will be to the look and feel of your screens.
